

RIDER TO AGREEMENT WITH VOLUNTEER, RELEASE AND WAIVER

This Rider is an amendment to the Agreement with Volunteer, Release and Waiver (the "Agreement") between the Volunteer named below ("Volunteer") and Unite for Sight, Inc., a Connecticut nonprofit corporation (UFS"). To the extent provided below, this Rider modifies and supplements the Agreement, and in the event of a conflict between the terms of this Rider and the terms of the Agreement, the terms of this Rider shall govern. In all other respects, the terms of the Agreement remain in full force and effect as originally written.

1. Volunteer is an eye care professional with the license described at the end of this Rider. Volunteer's license as such is current and Volunteer is in good standing with the licensing authority of the named jurisdiction. A copy of Volunteer's current license is delivered to UFS with this Rider. Volunteer will have a copy of Volunteer's current license with him or her at all times while participating in the Program and will exhibit the license to the sponsor of the Program or local licensing authorities at the site of the Program when requested to do so.
2. Because of Volunteer's professional qualifications described in paragraph 1, Volunteer is exempt from completing the training provided by UFS as described in Section I.C of the Agreement.
3. Despite Volunteer's license described above, to comply with applicable law in the country where the Program is conducted, Volunteer may be required to be supervised by locally-licensed eye care professionals, and Volunteer agrees to comply with such supervision requirements in all respects.
4. Due to the anticipated contribution Volunteer will make to the Program, UFS agrees to pay for Volunteer's travel to and from the Program site, as described at the end of this Rider. If Volunteer elects to travel by a mode of transportation, carrier or class of service different from that specified below, Volunteer will be solely responsible for the cost of such alternative travel or lodgings.
5. Volunteer acknowledges that to minimize cost to UFS, as a nonprofit organization, UFS may contract for Volunteer's travel on a non-refundable or partially-refundable basis. If, for any reason, after the date of this Rider Volunteer does not participate in the Program or elects to make arrangements for travel or lodging different from those described below, Volunteer shall reimburse UFS for the costs of the travel and/or lodging specified below within 15 days after receipt of invoice from UFS.
